

## PRIVACY AND COOKIE POLICY

Dear User,

with this document, in compliance with articles 13 of Regulation (EU) 2016/679 (hereinafter only “GDPR”), we provide you with the information concerning the processing of your personal data that is carried out in this website.

### DATA CONTROLLER.

The Data Controller is the company Texcar S.p.A., with registered office in Prato (PO), Via Montegrappa, 304, fiscal code and VAT number 00322200973, e-mail [texcar@texcar.it](mailto:texcar@texcar.it), tel. 0574-679671 (di seguito solo “Titolare”). (hereinafter only “Controller”).

### GENERAL DEFINITION OF COOKIE.

Cookies are small text files that are automatically placed on your computer or mobile device when you visit almost all websites. They are stored by the Internet browser. Cookies contain basic information about your use of the Internet, but do not identify you personally. Your browser sends these cookies to the site every time you visit it again, so that it can recognize your computer or mobile device and personalize and improve your experience on the site.

### TYPES OF COLLECTED AND PROCESSED DATA.

The website does not acquire any of your browsing data and uses only non-tracer cookies, necessary to keep the website language selection section active. It remains active only for the duration of navigation on the site and has no further purpose.

### PURPOSE AND LEGAL BASIS OF PROCESSING.

The collected data is processed to pursue the purpose of allowing a correct use and browsing on the website. These processings are performed respectively on the **legitimate interest** of the Data Controller to provide an adequate service through its website.

### DURATION OF DATA PROCESSING.

The cookie used persists until the user closes the browser.

### RIGHTS OF THE INTERESTED PARTY.

Finally, we remind you that at any time, with communication to be sent to the Controller to the addresses indicated in Section 1, provided that the conditions of law are fulfilled, you can exercise the **right of access** and obtain the **erasure, updating, rectification** of inaccurate personal data, **completion** of incomplete personal data and **restriction** of personal data concerning you, as well as exercise all the rights provided for in Chapter III of the GDPR and in national laws in the matters within their competence, where the conditions are met. You may also **receive** personal data relating to you **in a structured and commonly used format**, readable with an automatic device. In accordance with the provisions of article 77 of the Regulation, you may lodge a **complaint** with the competent Data Protection Supervisory Authority if you believe your rights have been violated. If the processing is based on our legitimate interest, you may finally, in accordance with the provisions of article 21 of the Regulation, at any time **object** to processing of personal data for reasons related to your particular situation.

### MANAGEMENT / DISABLING OF COOKIES

In some browsers it is possible to set the rules to manage cookies, an option that offers a more precise control on your privacy. This means that you can disable cookies used by this site or make a specific choice for each one of them.
